Safeguarding and Welfare Requirement:

Staff qualifications, Training, Support and Skills

At least one person who has a current paediatric first aid certificate is on the premises at all times when children are present and must accompany children on outings.

Health Providers must ensure there is a first aid box accessible at all times with appropriate content for use with the children. Providers must keep a written record of accidents or injuries and first aid treatment.

3.2 First Aid

Policy Statement.

At Coniston Early Years Centre staff are able to take action to apply first aid treatment in the event of an accident involving a child or adult. At least one member of staff with a current first aid certificate is on the premises, or on an outing at any one time. The first aid qualification includes first aid training for infants and young children. We aim to ensure that first aid training meets the current legal requirements and is relevant to staff caring for young children. We aim to have all staff trained in first aid at all times.

Procedures

The first aid kit.

Our first aid kit is accessible at all times, complies with the latest Health and Safety (First Aid) Regulations 1981 and contains the recommended items as prescribed by the most recent legislation.

- The first aid boxes are easily accessible to adults and are kept out of reach of children.
- We have five aid kits and they are located as follows;
 - In the main pre school room the first aid kit is located on the unit nearest the exit so that it is easily accessible in the event of an emergency evacuation and is also relatively central to all rooms.
 - In the kitchen the first aid kit is located near to the food preparation area.
 - The third kit is located in the outings bag in preparation for planned and spontaneous outings.
 - The fourth kit is located in the children's changing shed in the garden
 - The fifth kit is located in the staff room
- No un-prescribed medication is given to children, parents or staff.
- COVID19 and other pandemic illness - In the event of a return of Covid 19 or in the event of another pandemic all relevant government advice will be followed.

- PPE is available for all staff and should be worn if they are dealing with a suspected case of COVID19/pandemic illness at any point.
- At the time of each child's admission to the setting, parents permission for obtaining emergency medical advice or treatment is sought. Parents give consent on our electronic management system called Arbor.
- Parents give consent via Arbor at registration allowing staff to take their child to the nearest Accident and Emergency unit to be examined, treated or admitted as necessary on the understanding that parents have been informed and are on their way to the hospital.
